Conference on Evolving Landscape of IP Litigation in India & Abroad

Overview:

With the rise of IP litigation cases around the world in recent years, companies are under ever increasing pressure to reduce their legal, and in particular litigation costs. Smaller companies adopting necessary measures to avoid unnecessary IP litigation and some preferring alternative dispute resolution strategies. This eventually decreases the cost and time; however, these strategies bind only both the parties and does not set a public precedent. So there is always confusion whether to go for Out-of-court settlements or through Courts proceedings.

IP Litigation in India has steadily increased over last 10 years. The courts in India are increasingly conscious of the importance of awarding damages. However, most patent litigation in India is instituted by foreign entities and instituted mostly before the Delhi High Court. Also, most of the cases are pending and no standard system to access IP litigation suits for general public. The creation of new commercial courts are a step toward improving India's IP regime, however special Forums and Treatment of IP with experienced IP judges are something still to be implemented, apart from having IPAB to clear pending cases.

IP Litigation may be a lengthy process & cost incurring practice, but it retains the right of an owner and serves as a factor for enforcement of IP. One has to implement & follow a right strategy, choosing the right IP bucket to get the early orders from courts. With this background, the Technology Centre of Confederation of Indian Industry (CII), in association with United States & Trademark Office (USPTO), is organizing the 3rd Edition LITCON 2017 - a one day conference on IP Litigation with theme 'Evolving Landscape of IP Litigation in India & Abroad' on 24th November 2017 at Chennai.
