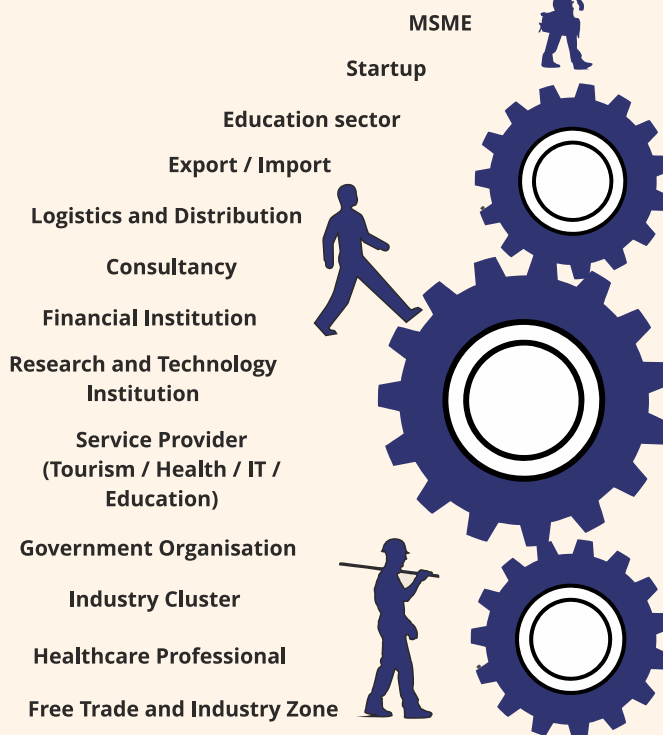
Connect, Calibrate and Collaborate

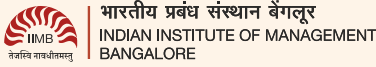
